2. Reason for change

Since its founding in 1982, with the goal of becoming the “top food service company in the world,” the Company has grown to become the number one company in Japan and one of the top ten in the world in terms of revenue in the food service industry. Aiming for further growth, the Company has entered a new stage to step up its global business expansion. Furthermore, in light of increasingly unstable global conditions, the Company evolved its corporate founding philosophy of “eradicating hunger and poverty from the world” in 2023, and pledged a new commitment to “taking responsibility for the stability and development of human society through food.”

In this new stage, the Company has decided to strengthen its management structure in order to realize the corporate philosophy and achieve further growth in the future.

Yohei Ogawa, who is scheduled to be appointed to Representative Director, President & CEO, has been involved in all aspects of management strategies since joining the Company in 2016 and responsible for the overseas take-out sushi business added to the Group from 2018, playing an important role in the growth of the Company. Under the new management structure with the founder Kentaro Ogawa as Representative Director, Chairman and Yohei Ogawa as Representative Director, President & CEO, the Company will further accelerate its growth while striving to sustainably increase its corporate value and realize the corporate philosophy.
